To seek approval for an 8.96 metre Building Line setback to accommodate the construction of a new dwelling at 118 Brookfield Road.

Discussion – Background and Current Status:

An application was submitted to subdivide the property at 118 Brookfield Road to create a new building lot to construct a Single Detached Dwelling. The property is situated in the Residential Low Density (R1) Zone where the minimum Building Line for existing streets or service streets is to be established by Council. The proposed set back of 8.96 metres is consistent with varied pattern of development of the other properties on the street.



Issue: To inform Council of the outcome of the call for volunteers for the short-term Youth Engagement Action Team (YEAT) and the next steps in the creation of a Youth Engagement Strategy (YES).

Discussion – Background and Current Status:

In June 2019 Council approved a recommended approach to develop a Youth Engagement Strategy (YES), an action item outlined in the 2019 Strategic Plan Action Plan.

On Oct. 1, 2019, staff from Organizational Performance and Strategy (OPS) met with the City's Youth Advisory Committee (YAC) and other invited guests in the 15 to 35-year old demographic to discuss the approach to developing a strategy and to further refine the intention of the YEAT. It was clear from that meeting that the call for volunteers had to be simple to encourage already busy young people to apply.

Therefore, when the call out for volunteers was issued, no forms were required. Those interested simply had to send an e-mail to engage@stsjohns.ca outlining why they wanted to be involved and to provide the following:

- Name
- Age
- Where you live?
- What you do?
- Can you commit to meetings, either in-person or online, during November and December?
- Anything else you think we might need to know about you to ensure we have a good representation of youth across the city?

An <u>engagestjohns.ca</u> page was created and a promotional strategy using a combination of video, posters, social media, announcements, and advertising was initiated to promote the YEAT to get young people interested to put their names forward. Information was also sent to a variety of organizations engaged with youth.



Fifty-five applications were received and reviewed, and 25 individuals were selected. The selection committee was comprised of staff from OPS, Recreation, and Councillor Burton. While not all who expressed interest can be part of the team, everyone will be encouraged to stay involved as YEAT carries out its work.

Those selected will be contacted to get plans underway for the first meeting. Once the group meets, a detailed plan will be put together to guide the development of the strategy. It will be important to be sensitive to the time of year when scheduling meetings to allow for meaningful engagement. Should anyone selected be unable to participate, we have also developed a second list to draw from to replace them.
