**Issue:** Provide an update on the City of St. John's Affordable Housing Strategy 2019-2028 and main areas of work

#### **Discussion – Background and Current Status:**

The City of St. John's approved the Affordable Housing Strategy, 2019-2028, in November 2018. The strategy will address the municipality's housing needs by working in step with partners, stakeholders and residents to create and maintain safe, suitable and affordable housing throughout the city. The following is an update on the main areas of work.

#### **CHTC**

We spoke with CHTC in July regarding the two proposed partnerships: matched Catalyst funding and the development of a shared facilitator resource. CHTC confirmed that they maintained interest in these projects and were now able to move forward. We have our next meeting with them on August 17<sup>th</sup>

#### **Community Response Fund**

The City of St. John's is a recipient of the COVID-19 Community Response Fund for Vulnerable Populations- A collaboration between the Federation of Canadian Municipalities and the Canadian Medical Association Foundation. This funding allows for recipients to support vulnerable populations struggling with the impacts of the COVID-19 pandemic.

The City will use the Community Response funding it received to establish public wifi access points. This project would help close a digital divide that has emerged in the Pandemic. Many low-income individuals rely on public internet but due to COVID-19 closures, libraries, coffee shops and cafes are no longer accessible. We have chosen two open space park areas that are near non market housing and outreach service locations. These locations are owned by the City and have the infrastructure required for wifi to be set up.



A limited call RFQ for Internet services has been issued and will close on July 29th. The RFQ asks for 1, 3 and 5 year pricing options.

Any remaining funding from the wifi project will be used to set up handwashing stations in the same areas.

#### Land

Eric Street project- Habitat for Humanity submitted a rezoning application, however some revisions were required. Staff recently received a revised site plan from Habitat for Humanity which is being evaluated. Following staff review, the application will be brought forward to Council for direction on the proposed rezoning. Should the rezoning application move forward, public consultation will be held.

Concerns from the neighbourhood were recently raised to the City that there is sewage leaking on the property. To the best of our knowledge, there is no sanitary sewer leaking underground at the property. ### Workshops

Planning for an affordable housing workshop series in partnership with CMHC has resumed. We continue to work on logistics together so that this series can be put off in the fall virtually.

#### **Property Standards**

We held the 'Safe and Healthy Housing' presentation for Stella's Circle staff. Inspection services has agreed to resume presentations virtually if there is interest.

## **Social Marketing Strategy**

A social marketing campaign has been created to tackle the fears associated with affordable housing through increased information (awareness campaigns, success stories, etc.) and focusing on the benefits of affordable housing. Three videos are complete and a revitalized website to accompany these videos is now being created. This has been postponed for the time being, but we may consider launching in the fall.

#### **Discussion – Background and Current Status:**

At the Committee of the Whole Meeting on July 8<sup>th</sup> Deputy Mayor Sheilagh O'Leary provided the following update on the City's housing units and vacancy rates:

Since the media blitz on February 20, fourteen individuals and/or families have been housed. There is work being done on several units at Forest Road and Riverhead Towers. When these units are rent ready there will be a campaign to further promote those vacancies.

The City maintains a wait list however the list is mostly for the rent geared to income units whereas vacancies are concentrated in the 3-4 bedroom lower end of market (LEM) units.

Deputy Mayor O'Leary requested that at the next meeting of the Affordable Housing Working Group an addition is made to the agenda to 'discuss creative ways to ensure housing units are accessible to the people who need them'.

We would like to invite suggestions from the AHWG for creative partnerships and models to consider with respect to this part of the City's housing portfolio (LEM, 3-4 bedroom units).
