## **Decision/Direction Required:**

To appoint a younger generation cyclist to the Bike St. John's Advisory Committee.

## **Discussion – Background and Current Status:**

Section 3.1.1 of the Bike St. John's Advisory Committee provides for the appointment of a younger generation cyclist.

*(Public member, aged 19-35) will be appointed to each advisory committee. Such individuals must be between the ages of 19-35 at the time their application is submitted.*

Recognizing the existing member's resignation in November 2020, a call for interested persons was advertised with the deadline for applications being December 18, 2020. A total of six applications were received.

Through consultation with the City Clerk's Office and the Team Lead (Marianne Alacoque), Alida Zedel is the recommended candidate.

Alida is a MUN student who rides year-round for recreation, sport, and commuting. She's been biking around St John's with her family since she was a toddler in a bike trailer. She believes its important that as a community we take advantage of the healthy lifestyle that cycling offers and the significant environmental benefits that it provides. She offers that weather in St. John's is not always favourable for cycling; we have rain, wind and snow and on top of that many roads have steep hills. But, we can work around these roadblocks because as a compact city, St John's has a great deal of potential cycling. She suggests that we will only get more people riding in St. John's if we take steps to reduce the difficulties and remove the barriers and hazards.
