**Issue:** Additional feedback regarding the Emergency Preparedness presentation.

**Discussion – Background and Current Status:** During the November 26<sup>th</sup> meeting of the Inclusion Advisory Committee, David Day, Manager of Emergency Preparedness with the City of St. John's presented information regarding the January 2020 State of Emergency.

David provided clarification regarding Emergency Response which is coordinated by the Province through the Emergency Services Act. As noted in the minutes, Inclusion Advisory Committee members provided feedback and were asked to bring the information back to their respective organizations for additional thought. CNIB provided the following feedback for discussion:

- Communication – the City of St. John's website is challenging to navigate, and it is difficult to know where to find accessible information
- Would like a dedicated phoneline (not 311) that can connect everyone to all available information. E.g. different organizations who are equipped to managed complicated issues as it relates to living with a disability.
- Before another emergency occurs, pre-determined locations in place with a plan so that the resident of the city will know where they should go in case of emergency, whether it be power outages, health concerns etc., access to food or to prescriptions.
