#### **Decision/Direction Required:**

Request for parking relief at 79-81 New Gower Street to accommodate a new Outdoor Eating Area (rooftop patio).

## **Discussion – Background and Current Status:**

An application has been submitted for an Outdoor Eating Area (rooftop patio) in relation to the existing Eating Establishment and Lounge at 79-81 New Gower Street, which is in the Commercial Central Mixed Use (CCM) Zone. The proposed patio will be 39m<sup>2</sup> and will require 8 parking spaces based on the Parking Requirements for an Eating Establishment under Section 9.1.1 of the Development Regulations.

Parking relief is required for eight (8) parking space. Under Section 9.1.2 Council can relieve some or all the parking required. The proposed property has no available onsite parking spaces and although the property is within the downtown core, the site is just outside the Downtown Parking Area. Based on the nature of the proposal and the location of the business within the downtown, the site is accessible by walking from nearby parking areas and transit stops.
