An application was submitted to construct a Single Detached Dwelling at 6 Winter Avenue. The property is located within the floodplain and buffer and as per Section 11.2.4.(2.1), Council may permit residential development in the floodplain and buffer of the Rennie's River at 6 and 8 Winter Avenue. During the text amendment process this application was referred to the Environmental and Sustainability Experts Panel (ESEP) as required under Section 11.2.4(3), who provided their advice to Council during consideration of the amendment.

This property is zoned Residential Low Density (R1), where the minimum Building Line for existing streets or service streets is to be established by Council. The proposed Building Line is proposed at 7.02 metres, which is consistent with the pattern of development along the street.
