To seek rejection for a Crown Land Grant for a Residential Use at 1040 Main Road.

## **Discussion – Background and Current Status:**

The Provincial Department of Fisheries, Forestry and Agriculture has referred an application for a Crown Land Grant at 1040 Main Road for 0.19 hectares. The land is proposed to be used for a Residential Use and is zoned Rural Residential Infill (RRI), Rural (R) and Watershed (W). This area is located outside the Gould's Ultimate Service Area, therefore no development, whether serviced or unserviced, may be permitted except for infill development consistent with existing zoning. As there is no surrounding development, this area does not meet the criteria for infill development. A portion of the proposed grant is also located within the Watershed Zone, where residential development is not a Permitted or Discretionary Use.
