This email is a brief comment on the application for 'A Change of Non-Conforming Use application has been submitted by Islamic Circle of North America at 47 Smith Avenue'

I wish my comments to remain anonymous on records.

The change in hours from what would be considered typical day hours to include all but 4 hours each day, for 7 days a week, is a drastic change. Any request for a drastic change such as this should come with a justification as to why the change is requested? The new hours include very early and very late hours - is this to accommodate all 5 times of Muslim worship per day? Is this because the Place of Worship in question intends to become also a place of shelter? Independent of the reason for the change of hours, why the change now? Further, it seems that this change can come with very early (just before 4 am) or very late (just after midnight) car and people traffic and thus noise. The Place of Worship is in very close proximity to adjacent houses (it is sandwiched closely by houses on all sides), with residents who will surely be disturbed by such traffic. This is different from many other Places of Worship that are more spatially isolated from nearby residential homes and that do not operate at such very late or very early times. I suspect discussion centred around this point is reasonable.


It's not a business with people coming and going throughout the day so less spots are needed, everyone is coming at once.

I understand these are intended to be for Ramadan only - but what is to stop the occupants from coming in at 4am every single day?

The houses on the street are VERY close to this building and the parking lot is so small and close to the houses, there is also a lot of street parking that is used due to the small size of the parking lot (making the noise even closer & louder to the houses). The amount of noise from people coming/going, car doors closing, etc. at this hour of the morning would be tremendous and would impact the community negatively.

This is not a residential street with a church where there's a huge parking lot and/or land mass buffer from the building to reduce noise to the nearby houses, such as Frecker Drive, Craigmiller Ave, etc. The houses on Smith Avenue and this building are so so close to each other.

The houses and this building are so close and noise is heard so clearly that the prior occupants actually used to give out "apology gifts" each year to the neighbours for the noise we endure from them throughout the year, and that is with them only using the building basically Wednesday evenings & Sundays all day until 8pm.

I do truly love the idea of another religion & culture finding a safe space and to be welcomed into the community - but not at the cost of interfering with the (majority senior) neighbours having to hear noise at 4am consistently. I really need to stress how close these houses are to this building – this is a very small residential street.

the houses next door and behind are 10 feet away from this building.

I don't think a blanket extension of the hours to be 4am - 12pm just to cover a holiday season is appropriate. If they have to apply to change the hours to accommodate Ramadan each year I do not see how that is an issue beyond making more work for the city.

The main worry is, if these hours are set for them 24/7 365 - what is to stop the occupants from using the building year-round during these hours? The below link shows the prayer times, if these hours are approved, I do not see why the occupants would not use the building during these hours year-round as it would be completely within their rights to do so.

I completely understand all of that.

Everyone can say it won't be loud, the occupants will be respectful, but as you know, it only takes one person to ruin things for everyone who is being respectful.

My first confusion is why did the city first say it was only for Ramadan? Where did this information come from? There has been so much conflicting information given it is impossible to make an informed opinion on this issue.

Also what every single person seems to be ignoring in this situation, is *how close this building is to the houses*. No other prior spot for this group, nor any other church in the city, is this close to the houses. The two houses on the side are within 10 feet (or closer) of cars being parked.

I have gone and drove past all the churches & buildings being used for worship on residential streets and none of them are even close to being able to be compared to how very very close this building and parking lot is to the houses. I don't understand how everyone is ignoring this when trying to make comparisons. 4am - 12am in this particular building and is completely unacceptable.

- regardless of if 1 person shows up at 4am or 100, every single bedroom surrounding is going to hear these people at this time, then again at 12am.

Also, everyone keeps ignoring the size of the parking lot.

The parking lot can fit 6 cars, maybe. How is this even allowed? For a building of that size and usage.

Currently, on Wednesdays and Sundays, the occupants block each other in on the lot, then a third car is parked on the street, blocking the inside car in with 2 cars. To me, this seems unsafe - although this is a completely different issue. The parking lot just isn't big enough - there's no making it larger.

No one is addressing the actual issues that this would cause the residents. Every single point that would actually affect the home owners in this area is disregarded completely.

4am - 12am is completely unacceptable for where this building is located, and the proximity to houses. It is truly unlike any other similar building in the city because of the time it was built and it being able to be so close to the houses.

I truly hope this group finds a space, but this building is not in the right place for something with hours of 4am - 12am, 7 days a week, being closed only 4 hours a day.

This particular building and its unique layout within a small residential area need to be considered - and everyone is just ignoring the space this building is in and how it affects this application.

Hi

This is, in fact, the first I've seen of these emails, and my apologies for that -- we have a very aggressive spam filter at the City that routinely deletes things it shouldn't, and I'm wondering if this could have gone that way. I'm aware of the proposal for 47 Smith, and as you have noted, the information I have been provided strongly suggests that the masjid will be used for early-morning prayers almost exclusively during the month of Ramadan. This is in line with what I'd expect with my (admittedly limited) understanding of Islamic practices, particularly in the context of Islam as it exists in this city and province.

As I understand it, most Muslims globally -- and certainly all of those I know personally -- do not pray in communal settings for all five daily prayers, but instead perform either some or most in other settings, often in the home (and that's assuming they do all five, which many do not.) The fajr (dawn) prayer is the most commonly dispensed with in this way except during Ramadan, when the obligation for communal worship is considerably stronger, hence the early start times during Ramadan that you mention. Even then, many of the communal prayers can take place in different settings; as an example, it was for quite some time, and may still be, the case that Muslim students of MUN had a designated campus prayer room, particularly for dhuhr (noonish) and asr (afternoon) prayers. The existing Masjid-an-Noor mosque at the other end of town also hosts these students and most other community members for the Jumu'ah (Friday afternoon) prayers, which are typically the busiest, and I believe for some Muslims are also the only prayers they routinely attend in such an environment. If I'm right about that, I would wager that the experience of having a masjid on Smith Avenue is unlikely to deviate significantly from the former St. John's Gospel Hall as far as neighbour experiences are concerned.

All of this to say -- I believe the proposed masjid on Smith is not likely to present major issues with congestion, routine early starts, or the like. When similar proposals have been brought before us in the past with very broad-ranging hours of operation, as one did recently for Canada House, it has often been the case that the goal was not to maintain regular business at those hours, but simply to avoid the necessity of endless discretionary-use applications or individual clearances for events or times of year when those hours would be necessary. The issue is not so much avoiding complication for City staff as

facilitating ease of use for the occupants; in this case especially, I am quite uncomfortable with the idea of making Muslims apply for this kind of permission annually when we do not require Christian churches to do so for things like seasonal midnight services. I'm honestly not sure if we even have the ability to designate extended hours as routinely acceptable only for limited times of the year, which would at any rate be particularly difficult with regards to Ramadan as the month begins and ends at a different time every year. My suspicion is therefore that the question of whether anything stops the occupants from routinely using the property at those early times is answered not so much by City regulation as by the nature of Islamic practice, and on this I hope I have provided some satisfactory comfort.

The Islamic Circle of North America are the proponents behind this masjid, and they do currently have a kind of drop-in building elsewhere in the city which is in some cases used for prayers; we also of course have Masjid-an-Noor as well, which has existed for quite some time. I don't recall coming across complaints about disruptive activities early in the morning for either of those, and I am confident this pattern will continue here. The members of our local Islamic community with whom I have dealt over the last 15 years have been faultlessly kind, supportive, and considerate of their neighbours, and I have no doubts that, should this proposal be approved by Council, yourself and the other residents of Smith Avenue will face no challenges in sharing space with them. Developments like this one are crucial precisely because they facilitate inclusion and equity for all members of our society; my support for them comes not at the cost of some residents' experiences, but rather with an eye to ensuring my Ward is the most accepting, systemically affirming, and welcoming place it can be for all our residents, in all our diversity. I sincerely hope for a future of mutual welcome, positive dialogue, and collective acceptance for everyone involved.

I understand these are intended to be for Ramadan only - but what is to stop the occupants from coming in at 4am every single day?

The houses on the street are VERY close to this building and the parking lot is so small and close to the houses, there is also a lot of street parking that is used due to the small size of the parking lot (making the noise even closer & louder to the houses). The amount of noise from people coming/going, car doors closing, etc. at this hour of the morning would be tremendous and would impact the community negatively.

This is not a residential street with a church where there's a huge parking lot and/or land mass buffer from the building to reduce noise to the nearby houses, such as Frecker Drive, Craigmiller Ave, etc. The houses on Smith Avenue and this building are so so close to each other.

The houses and this building are so close and noise is heard so clearly that the prior occupants actually used to give out "apology gifts" each year to the neighbours for the noise we endure from them throughout the year, and that is with them only using the building basically Wednesday evenings & Sundays all day until 8pm.

I do truly love the idea of another religion & culture finding a safe space and to be welcomed into the community - but not at the cost of interfering with the (majority senior) neighbours having to hear noise at 4am consistently. I really need to stress how close these houses are to this building – this is a very small residential street.

the houses next door and behind are 10 feet away from this building.

I don't think a blanket extension of the hours to be 4am - 12pm just to cover a holiday season is appropriate. If they have to apply to change the hours to accommodate Ramadan each year I do not see how that is an issue beyond making more work for the city.

The main worry is, if these hours are set for them 24/7 365 - what is to stop the occupants from using the building year-round during these hours? The below link shows the prayer times, if

these hours are approved, I do not see why the occupants would not use the building during these hours year-round as it would be completely within their rights to do so.

All people are seeing is 4am - 12am, which is insane for any business to be open honestly within 10feet of homes on a small residential street.

Everyone I have talked to, if they managed to get a response from the city, all got completely different conflicting information.

In reading facebook comments (I know this can't be taken with any authority) - but no member has stated the hours are only for Ramadan.

There's clearly some sort of confusion in information here as each person I talk to at the city has given different information, none of which lineup.

From my understanding (which very may well be wrong but I can only go on what information I have been given, whether it's consistent or not) - is that the city is under the impression that these hours are only for Ramadan, but the people who will actually be using the building, speak nothing of this and say it's intended for year-round (whether 1 or 100 people utilize it at 4am, it will still be available to them).

I'm sure you can understand the frustration and confusion that we here as homeowners are currently experiencing.

Again, 4am - 12am in this particular building, with its layout and proximity to the houses, is still unacceptable - but the more (correct) information we get, the more informed opinion we can make on this.

Hi there,

I am not sure if the city is going to reply to any of my questions and numerous emails I have sent, but I will continue regardless as new questions come up, and my voice should be heard. Due to no communication from the city, I had to interpret this on my own, please advise me and I am incorrect with the below.

I have asked multiple times about the parking for 47 Smith Avenue (among many other issues that also received zero response) – I understand the building has been there a long time and the prior occupants were likely grandfathered in under prior rules, but this parking lot is EXTREMELY small for the size and use of this building.

Maybe 6 cars can fit in this lot, the occupants prior have used this lot by parking behind each other, blocking in the inside car, then the remainder park on the street, blocking in the inside car by 2 cars, and blocking the middle car – this to me seems extremely unsafe and shouldn't be allowed at all.

Even with all those cars blocking each other in, the amount of "spots" - still wouldn't even meet today's regulations and would be short of the minimum spots.

My confusion with this new application is, according to the development regulations, for a place of worship, there should be 1 parking spot for every 15 meters square.

The MLS listing says it is 5,222 sq ft - which is 485 metres square divided by 15 would be 33 spots.

This lot barely fits 6 vehicles safely.

How is this allowed???

There was never enough parking to begin with, but it wasn't that big of an issue to deal with twice a week for a couple hours, and I assumed it was allowed because it was built before a time when these regulations existed.

Now there will not be enough parking, and the building is basically open 24 hours a day 7 days a week.

Please let me know if I am interpreting these regulations incorrectly, but no one will answer any of my questions, so I must make my own assumptions based on existing city regulations.

How is an application for this type of use of a building allowed if the parking doesn't even come close to the city's regulations??

I don't understand why no one is responding to any of my inquiries – this experience has been horrible and it's very clear the city is not concerned about the home owners and residents in the slightest. I am so discouraged and disappointed in how this has been responded to by the city, I've lived here my entire life, I own a home, I contribute to the community, and I cannot get one response from anyone in the city.

I would love to be proven wrong and finally get a response, my emails have been respectful and have asked important questions that myself, as a resident and homeowner in this area, have the right to know the answers too. To be disregarded and ignored in this way is truly not okay and I hope my experience is a one-off and not every resident is treated in such a disrespectful manner.

It is our hope that this will continue with the new owners of 47 Smith Ave. We are dismayed with the new owners application of proposed increased services up to four hours earlier and four hours later seven days a week than what was historically carried out at 47 Smith Ave. Specifically, we are concerned with possible overflow parking on the street other than the place of worships own parking capacity and increased noise due to increased activity to twenty hours a day, seven days a week during hours where the neighborhood is usually at rest and asleep. and normally wasn't an issue under the current hours as services didn't take place during quiet hours respecting the neighborhood peace and quiet. It is unusual that a place of worship is in such proximity to residential homes in this manner. I have happily lived in this same residential area since and an analysis and I greatly appreciate the excellent service we have had from the City of St. John's maintaining this area over those years. I have not had one incident with the City in that time. As for this application, my concerns are:

- The area around 47 Smith Ave is very residential, and I do not understand or agree with a "Place of Worship" needing a starting hour of 4:00 AM and a closing hour of 12:00 PM for seven (7) days a week for worship services. I believe that services going on at those hours would be a disturbance to the residents in all the nearby area. This area of Smith Ave and Grenfell Ave is not compliant for these early and late hours of activity, and I would humbly suggest that a more "industrial area" would suit the hours being requested in this application for this church/business.

-

- o The last church group who owned 47 Smith Ave used much of Smith Ave (north of Pennywell Road) and Grenfell Avenue for parking during church services. The "on-site parking" on 47 Smith Ave was never adequate for the number attending the church services and a proper amount of parking space should be available for a new church purchasing the property. They had services at 9:30 AM and 11:00 AM on Sunday and street parking was workable for those later hours of worship.
- o If a Place of Worship is starting at 4:00 PM and ending at 12:00 PM for 7 days of the week, I would expect that parking on the streets would happen at early and late hours and a level of noise would come with that in the early morning hours and late hours. I believe that would be disturbance during the time frame proposed in the application.
- o Activity and worship for a church, at such an early or late time of church worship, would disqualify a church having a starting time that early or an ending time that late in a quiet neighbourhood such as Smith Ave and Grenfell Ave.
- o I do not know how many people will be attending services in the building on 47 Smith Ave but the number of people should equate to the parking space available on the property parking lot code for this building. And I think that the use of Smith Ave and Grenfell Ave should not be an option for a church applying for this new property. I would expect the city to enforce the parking code for this building property on 47 Smith Ave.

I am pleased to see a church group applying for the property on 47 Smith Ave. But from the lack of information available regarding the number of people and the number of vehicles, the amount of noise, activity, and for those early and late hours being requested in the application, and the lack of adequate parking for the property, hence: I am fully against the application for a "Change of Non-Conforming Use" by the Islamic Circle of North America at 47 Smith Avenue.

I am writing in response to the Change of Non Conforming Use application that has been submitted by the Islamic Circle of North America for 47 Smith Avenue and their request to change the hours of use to 4 a.m - 12 a.m seven days a week.

I am 100% against this application.

I feel the request to open a Place of Worship at 4 a.m (which is the middle of the night) and stay open until 12 a.m seven days a week is beyond unreasonable. Smith Avenue and the surrounding streets are a quiet residential area where most residents work normal business hours (usually starting at 8 a.m) and others are retired seniors. I have never heard of a place of worship operating those kind of hours and everyday. That is unheard of.

I live at

Allowing this request will have grave consequences for the residents of our street plus the neighbouring streets:

- increased traffic especially when residents are sleeping.
- It will create more noise (car doors opening/closing, people talking) during the time when residents are sleeping and when they are heading to bed for the night. This will certainly wake residents and disturb them during hours they are sleeping.
- it will have an effect on snowing clearing as those attending the Place of Worship will certainly park on the street as well. This will make it difficult to clear snow from the street if open that many hours.
- If the building is only closed from 12:00 a.m. to 4:00 a.m. the building parking lot will need to be cleared of snow during those times thus waking people up.
- because of the increase in traffic and noise, it will reduce the value of the houses and the ability to sell a house (should someone decide to do that) of those in proximity to this building.

With the increased traffic and noise this will create, I'm sure it will be against the noise by-law.

I have spoken to the majority of the residents within 150 metres of 47 Smith Avenue (this would include Smith Avenue, Grenfell Avenue, Pennywell Road and Prowse Avenue) and we are all against this request. One common theme has come up which was the need for more information. No details were given on what will be happening there for 20 hours per days. I feel there should be some consultation with the residents so they can voice their concerns before any final decisions are made.

One of my neighbours spoke to a representative in the City Clerks office and she was informed that they have received numerous calls concerning this request. Obviously it is a topic of concern for the residents.

During my research on this matter I discovered the **Envision St. John's Development Regulations (As Amended November 2023)**. In that document on page 8-3 the regulations for Place of Worship are "1 parking space for every 15 square meters of Gross Floor Area". The area for the building on the notice was 485 square metres . This would mean it would need 33 parking spaces. There are only 20 spaces for this building. By the regulations in the City of St. John's document there are not enough parking spaces for this Place of Worship. This alone is a reason to reject the application. I have attached a screenshot of the section regarding Places of Worship plus the envision document.

I certainly hope our elected members of council do the right thing and listen to the effected residents and reject this current request and ask the applicant to submit a more reasonable request which would be hours of operating no earlier than 8 a.m and no later than 9 p.m. (which was the previous approved time). Also a reduction in the number of days per week to something more reasonable and in line with other places of worship which is 2 - 3 days per week.

I have also added a petition signed by the residents I have spoken with. This clearly shows that the residents who do live in this area are not in favour of this application.

The members of council need to ask themselves, if this was requested on your street how would you feel. I don't think you would want increased traffic and noise during hours while you are sleeping.

If this request is approved I know it will lead to numerous calls to city hall and the police for complaints of noise and increased traffic.
