1. 1-5 Petty Harbour Road — MPA2400009

Councillor Davis questioned if there would be any conflict with the planned use for the adjacent land in the area. Staff advised that there were no concerns.

Further, upon receiving a satisfactory site plan, that Council refer the application to public notification, as the application will require a commissioner's public hearing later in the amendment process.

2. 2024 Heritage Financial Incentives Program

Deputy Mayor O'Leary asked if the provision of grants would allow applicants to avail of additional opportunities for funding. Councillor Burton responded that although there was a slight reduction in the maximum amount for grants, the reduction was minimal and should not affect the planned work of applicants. While municipal funding is often used as a stepping stone to unlock additional levels of funding, the City is the only level of government offering assistance for heritage maintenance and conservation.

34 New Cove Road - MPA2300005

Councillor Burton advised that the applicant was seeking the direction of Council and Staff on the stepback requirement of the Development Regulations before completing their Land Use Report (LUR) for 34 New Cove Road. Stepbacks are required for buildings that are 12m or higher, as they regulate building form and reduce the negative impacts of wind, shadow, privacy, and precipitation on neighbouring residences. While there are many benefits to requiring stepbacks on such developments, Staff recognize that Council must consider the economic challenges facing developers and the need to find a balance between the planning standards and current the need for housing. The current applicant has provided Council with their justification for their amendment to the stepback regulation and provided a shadow study demonstrating that the difference in the impact of the stepback requirement were negligible. The requirement would also result in the loss of a number of units due to the increase in construction costs. It was predicted by Staff that there would be an increase in proposals for taller buildings, and that Council would need to make a decision concerning stepbacks for development moving forward. Amendments to the Development Regulations would be required.

Councillor Burton agreed with the applicant that the stepback requirement could be considered on a case-by-case basis. Should an applicant wish to have Council relieve the requirement, justification for the request must be provided. The LUR should demonstrate the wind, shadow, privacy, and precipitation impacts on neighbouring residences. She then made the following motion:

 That Council consider an amendment to the requirement and direct staff to carry out public consultation for an amendment to the Regulations as part of the public consultation for the proposed rezoning of 34 New Cove Road. Members of Council agreed that consideration should be given to making the requirement discretionary, noting the importance of the information that would be included in the LUR. Developers were encouraged to contact Council to discuss future projects.

4. Approval of the Building Safer Communities Strategy

The Manager of Healthy City and Inclusion was in attendance to provide Council with background information and an overview of the Building Safer Communities (BSC) Strategy. Councillor Davis voiced his support of the Strategy as a living document as it provided opportunities to add additional focus to the prevention of child abuse. He stated that child abuse was a major concern and a root cause of violence and crime with detrimental effects. Members of Council noted that although many of the programs designed to address violence and crime were outside of the City's jurisdiction, it was important for the City to facilitate the work of community groups and advocate for legislative and policy reforms to address the root causes of violence and crime. The Strategy would act as a guide for applying a safer community lens when developing City policies and making decisions moving forward. Deputy Mayor O'Leary stated the importance of addressing poverty in the Strategy. Advocacy for the investigation of a guaranteed basic living income will help to address future changes to the workforce as work become automated and help to eradicate poverty in the community. Councillor Burton noted the importance of the work undertaken for the Healthy City Strategy. This work has laid the foundation for the BSC Strategy, and the pillars of the Healthy

City Strategy will continue to support the goals of the initiative. She asked residents to read the document as the information would help increase understanding of the scope of the work and the realities the CIty is facing when it comes to crime and violence.
