Decision/Direction Required:

Seeking Council approval to fund recommended projects under the Building Safer Communities Grant Program.

Discussion – Background and Current Status:

The <u>Building Safer Communities (BSC) Grant Program</u> provides funding to community-based service providers to develop or strengthen crime and violence prevention and intervention initiatives or programs for children, youth, young adults, and their families in the City of St. John's. This grant program was made possible thanks to a three-year funding commitment from Public Safety Canada, announced in February 2023, to enhance community safety and collaboration.

The 2024-26 BSC Grant Program was developed based on the priorities and goals of the <u>Building Safer Communities Strategy</u> as well as <u>Round Table</u> recommendations, Public Safety Canada funding criteria, a comprehensive review of best practices for addressing crime and violence, and what we heard <u>through public engagement</u>. It is included as an action item in the BSC Strategy:

6.1.1 Continue the <u>BSC Grant Program</u> until March 31, 2026, to address the root causes of violence and crime for children, youth, young adults, and their families. Projects must align with best practices noted in Section 4.2.4 and with the goals of this Strategy (p. 33).

On October 23, 2024, community-based service providers working with children, youth, young adults, and their families, were invited to <u>apply for funding</u> to expand or develop initiatives that address risk and protective factors and/or align with the goals and best practices outlined in Section 4.2.4 of the BSC Strategy:

- Wraparound Support Programs
- Family-Focused Programs



- School and Educational Programs (while schools are not eligible, community-based service providers collaborating on projects with schools may apply)
- Programs for Racialized or Vulnerable Populations
- Prevention Programs
- Recreational Programs

\$575,000 is allocated for the 2024-26 grant program.

Nine applications were received with a total request of \$809,128.88. An internal evaluation committee consisting of representatives from the Departments of Community Services and Finance and Corporate Services scored applications based on the criteria outlined in the program description. Evaluation criteria were approved by Public Safety Canada in keeping with the terms of the federal contract.

The evaluation committee is recommending funding for six projects totaling \$533,023.25:

The program consists of a 13-week intensive course for children, a concurrent 13-week caregiver/parent group, and additional support services such as one-on-one family counselling and school advocacy. Thrive CYN St. John's Inc.	This program is a continuation of the street outreach initiative currently funded by Building Safer Communities. YMCA of Northeast Avalon Inc.	The YMCA Alternative Suspension program is aimed at secondary level students who are experiencing difficulties in their academic and social development. Students ages 12- 17 will be referred to the program by their School Administrator for a period of 3 to 5 days. Funds will help support Alternative Suspension Program Coordinators to work with youth to develop personalized intervention plans to address identified risk factors and meet the needs of students while working on the objectives set by the school.	\$90,000	 Proposal aligns with BSC Strategy, What We Heard recommendations, best practices and identified gaps. \$94,428 requested.
YWCA St. John's Inc.	Creating Space is a gender- based violence (GBV) prevention program currently delivered in three local high schools (Holy Heart, PWC and Gonzaga). Through this project the YWCA will increase partnerships with high schools, while expanding age-appropriate content to deliver Creating Space in junior high schools. In addition to four- week groups and school-wide advocacy projects, the program will develop stand-alone, class- based workshops focusing on core GBV prevention topics aligned with the Safe and Caring Schools Policy. Funds will help support a full-time Program Coordinator, program materials and equipment.	\$69,800	 Proposal aligns with BSC Strategy, What We Heard recommendations, best practices and identified gaps. \$80,000 requested.

The six recommended projects best address Building Safer Communities and Public Safety Canada program goals, priority areas, and identified gaps with a focus on addressing the root causes of crime and violence for marginalized children, youth, young adults, and their families.

All projects funded through the 2024-26 program must be completed with final reporting provided to the City's satisfaction no later than March 2, 2026.

The continuation of any community projects funded through last year's BSC Grant Program (i.e., Thrive) will be subject to the satisfactory completion and reporting provided by March 31, 2025.

- 6. Accessibility and Inclusion:

The BSC Grant Program was developed to address risk and protective factors and/or align with the goals and best practices outlined in Section 4.2.4 of the BSC Strategy, which are noted above. Risk factors encompass negative elements in the lives of individuals or within a community. They have the potential to increase the presence of crime and/or violence, victimization, and/or the fear of crime and/or violence in a community. These factors may increase the likelihood of individuals engaging in criminal or violent behaviour or becoming victims themselves.
