As long-term residents of Topsail Rd, we see the increase in speeds, traffic, and distracted driving every day. With upwards of <u>70 vehicles</u> turning in and exiting at peak times, we do have suggestions we would like to see implemented.

- 1. Speed reduction signs to 40 km/h 500 meters before and after the entrance. I recall taking a Health & Safety course from one of the staff of Dallas Mercer Consulting (DMC), who I believe are the current building owners. The instructor said there had been 2-rear end collisions in a week. They met to discuss how they could reduce the chances of further collisions. Cars with rushing parents and children on board mean the clientele could be stressed and it is reasonable to give them a speed buffer.
- 2. Speed cameras in place to enforce fines to protect the public.
- 3. RNC presence the first several mornings to make drivers aware of the change of use.
- 4. Signage on Brookfield Rd and Topsail Rd highlighting children are in the area.

If we can slow down traffic for the children, parents and staff of the daycare, we hope that will lead to a reduction of collisions and speeding for all of us in this area of Topsail Rd.
