#### **Discussion – Background and Current Status:**

The Arts and Culture Advisory Committee provides information and advice to Council on matters related to arts, culture, Indigenous and intangible cultural heritage that intersect City policies, programs, and services.

Following the end of appointment for several members, a Call for Members was issued on behalf of the Arts & Culture Advisory Committee seeking the following:

- One organizational representative from the Literary Discipline
- Two organizational representatives from Cultural, Indigenous, and Intangible Cultural Heritage Organizations
- One community based public member with a strong interest in arts and culture.

The call was circulated in January and extended until March 2<sup>nd</sup>, resulting in 17 applications. The applications were reviewed by Lead Staff, who are recommending the following candidates for appointment:

- Fabienne Christophle of Fédération des francophones de Terre-Neuve et du Labrador, Cultural, Indigenous, and Intangible Heritage Organization Representative
- Kaitlyn Little, Community Based Public Member

After the call had ended, the Visual Arts Organizational Representative vacated their position on the Committee. Staff are recommending that Kristen Piercey of Visual Artists Newfoundland and Labrador (VANL), who applied under the recent call as a Cultural, Indigenous, and Intangible Cultural Heritage Representative, be appointed to fill the Visual Arts Organization Representative vacancy. A new Call for Members will take place to fill the vacant Indigenous, and Intangible Heritage Organization Representative position.
