Title: School Zone Time Update

Decision/Direction Required:

According to The Highway Traffic Act (HTA), a reduced speed limit is enforceable between the hours of 7 a.m. and 5 p.m. on school days. School zone signs will be updated citywide to have a speed limit of 30 km/h from 7:00 am to 5:00 pm on school days in alignment with the Highway Traffic Act (HTA). The update will extend the time that a reduced speed limit is in effect by an additional 30 minutes in the morning, changing the start time to 7:00am instead of 7:30am as currently posted on City signs. This change is being implemented in coordination with the rollout of the provincial image capturing enforcement system.

Discussion – Background and Current Status:

On February 2, 2015, Council approved the implementation of school zones throughout the city according to the recommendations from the Police and Traffic Committee. A 30 km/h speed limit was applied to all identified school zones, with the reduced speed in effect from 7:30 a.m. to 5:00 p.m. on school days.

The Highway Traffic Act (HTA) provides slightly different regulations for school zones, including the specific times when the reduced speed limit is enforceable "between the hours of 7 a.m. and 5 p.m. on days when school is regularly held."

In preparation for the upcoming roll-out of automated speed enforcement using image-capture technology, City staff will be aligning the school zone signage with the HTA regulations. This adjustment is to ensure consistency with provincial enforcement standards.

The signs will be updated before the first day of school on September 3, 2025.

To implement this change, school zone signs will be updated indicating the HTA-compliant times at the following schools.

Pennywell Road – vicinity of Bishop Abraham Bond Street - Bishop Field

School zone signs will be updated citywide to have a reduced speed limit of 30 km/h from 7:00 am to 5:00 pm on days when school is regularly held. This will bring the City's school zone times in alignment with the NL Highway Traffic Act (HTA). This change will apply to the following schools zones:
