# 14.3 Sale of City land adjacent to 22 Monroe Street

Councillor Davis requested clarification on the maintenance of the public works turnaround and pedestrian access as noted in the previous lease. While the City Solicitor could not provide additional information on the current use on the parcel of land, she did advise that if the land was conveyed, the property owner could restrict access if they wished to do so. She further noted that as the previous lease was over 20 years old, details concerning the lease were not currently available and the use may have changed since the original agreement was considered.

Members of Council noted that the Decision Note stated that the pedestrian access was not over the parcel of property in question and the City Manager advised that the sale of the parcel of land would have been sent to various departments for review. If the land was required for a turnaround or if it would impede a pedestrian access route, this would have been noted by Staff as a concern.

Noting the importance of maintaining pedestrian access routes, Councillor Davis made a motion to defer the item to allow for additional information on pedestrian access in the area of 22 Monroe Street.

Councillor Ellsworth reminded Council to direct any technical questions to Staff ahead of Regular Meetings. This helps avoid delays in decision-making and ensures Staff are prepared to respond to questions in the Council Chambers.

Councillors Burton and Davis commented on the presence of mature trees on the lot, expressing support for their preservation. Councillor Burton further suggested that it would be beneficial if the City had enhanced authority over the maintenance of trees on mature lots.

Councillor Noseworthy noted resident concerns surrounding the access to community mailboxes in the area. He asked that Staff contact Canada Post should access to the mailboxes be obstructed by the increase in density.

# 14.6 120 Messenger Drive - MPA2500005

Councillor Burton voiced her support of the Staff recommendation to reject the application, as it follows the guidelines provided in the Municipal Plan. She encouraged the applicant to reapply once a Comprehensive Development Plan was in place for the area.

Councillor Davis questioned the recommendation to reject the rezoning application and informed Council on his concerns with piecemeal development in the area. He felt that the current pattern of development without a master plan was inefficient, resulting in a lack of active transportation routes and amenities in area. He called on Staff to create a Comprehensive Development Plan for the area. He also voiced his support for the applicant as they would be increasing density in the City on land that is technically outside of the 190 m contour elevation limit for servicing and the Kenmount Comprehensive Development Area (CDA).

Councillor Ellsworth noted the importance of having a Comprehensive Development Plan and requested clarification on the process for creating such a plan. The City Manager responded that generally with CDAs the onus is on the developers to create a plan for their land. Should the City create the plan, they would be dictating to landowners what they can and cannot do on their land. It would be challenging for both the City and landowners to create a concrete plan that would satisfy both existing regulations and requirements as well as landowners and developers in the area. The Deputy City Manager of Planning, Engineering, and Regulatory Services advised that creating a Comprehensive Development Plan for the area would be expensive and time-consuming. Extensive consultation would be required, and it would be unfair to the applicant to add the creation of a Comprehensive Development Plan for Kenmount Terrace would have to brought forward for consideration as a future

Capital Budget project. The Deputy Mayor noted the importance of consultation and thoughtful development. She felt that consideration of the creation of a Comprehensive Development Plan for the area would be best left for future budget discussions. She also voiced her support for the current application due to its location outside of the area considered in the Kenmount Concept Plan for Lands Above 190-metres report.

The Deputy City Manager of Planning, Engineering, and Regulatory Services cautioned that should Council vote against the current recommendation, additional work will be required by the City to move forward with approval of the rezoning. Residential Development would require major infrastructure work and may be cost-prohibitive for the applicant. He further noted that approval of this application before the approval of a Comprehensive Development Plan would result in an increase in piecemeal development of the area. He reiterated that should Council wish to consider creating a Comprehensive Development Plan, they should refer it to a future capital budget for consideration.

Councillor Burton reminded Council that approval of the application would go against the City's planning principles and summarized the challenges for a Comprehensive Development Plan created by the City. She further advised that zoning allows the City to have control over development and when rezoning takes place or Development Plans are created, it is done in tandem with landowners and developers to ensure that both legislative requirements and community needs are met.

# 16.1 <u>Electric Bicycles and Scooters</u>

Deputy Mayor O'Leary informed Council that she had received some complaints concerning the use of electric and motorized vehicles in the Downtown Pedestrian Mall (DPM). She contacted City Transportation Engineering Staff concerning the issue and they advised that responsibility over the legislation of use of such vehicles would fall under Provincial jurisdiction. She noted the importance of working with the Province on the issue to ensure the safe use of motorized vehicles in pedestrian-friendly areas.

# 16.2 Forever Chemicals and PFAs

Deputy Mayor O'Leary requested information on the presence of forever chemicals, or Per- and Polyfluoroalkyl Substances (PFAs) in the City's water supply. The Deputy City Manager of Public Works responded that as the City has a protected watershed, such chemicals are currently not present in the City's water supply.
