Title: American Sign Language Training for Lifeguards

**Issue:** To provide the City of St. John's aquatics staff with the tools necessary to communicate common pool phrases with patrons who communicate using American Sign Language (ASL).

#### **Discussion – Background and Current Status:**

Lifeguards observed patrons at the H.G.R. Mew Community Centre swimming pool, who appeared not to hear the pool whistle at the end of the swim. The lifeguards did communicate through writing and hand gestures that it was time to vacate the pool; patrons were pleased and thankful.

The City of St. John's Inclusive Services team connected with Megan McGie, Community Support Worker with the Newfoundland and Labrador Association of the Deaf to determine if a resource existed to teach aquatics staff how to communicate common phrases used in pool settings. Megan agreed to provide the following sign language training options:

- Manuals with photos
- Video

The common pool phrases which will be found within these resources were gathered by Paul Reynolds Community Centre and H.G.R. Mews Community Centre Head Lifeguards, and can be seen below:

- 1. Away from the water, please
- 2. Swim is over or, Time to go
- 3. Walk please or, No running
- 4. Slow down
- 5. Off the rope! or, don't hang on the rope
- 6. On your back on the slide/feet-first
- 7. No floats in the deep end
- 8. No diving
- 9. No flippers! or, don't walk in your flippers
- 10. No facemasks
- 11. We have spare goggles
- 12. Under 8 years old needs a guardian



- 13. Where's your guardian? or, Who's with you? Or, Who're you with?
- 14. Can you swim?
- 15. I'll ask my supervisor/head lifeguard.
