Unless you actually live in the Cheeseman/Teakwood area, people have no idea what it is actually like. I'm not against a daycare at all, but the location concerns me. Living right on this corner, it is unbelievable how many close calls we have witnessed. The stop sign may as well not even be there, and speed has been a major issue since we moved to Southlands years ago. It is not a simple issue, and I understand that there are pros and cons. I think that the daycare itself sounds lovely, and that in the right location that it would be an asset to our neighbourhood. But I think we have just as many people against this application as we do supporters. It is also an extremely busy corner, on both sides of the road, for school bus routes. 




We received a letter in the mail regarding a discretionary Use application for a Day Care Center at 110 Cheeseman Drive.

I would like to express my opinion on the following:

- I have concern over the increase in ambient noise conferred by any commercial development, but likely exaggerated due to outside playtime at the proposed childcare facility and traffic at drop off and pick up. Essentially many residents including myself would be subject to their backyards adjacent to a playground for the 60 children as the proposed daycare is literally in resident's backyards.
- I also worry about the impact on the value of housing in the area. I feel that a large daycare would greatly diminish the value of property. I wonder about the massing and design of the building and question if it would be appropriate for this residential neighborhood.
- I have raised concerns about public safety and infrastructure impacts. Increased traffic in the area raises many safety concerns as this neighborhood is home for numerous young

families. Presently I have concerns with the volume and speed of traffic in this area and the additional traffic flow from the daycare would certainly compound the problem.

With workers as well as clients racing to make drop off and pick up times 5 days a week, traffic will increase 10 fold as well as the chance of someone getting seriously injured or heaven forbid worse. With children waiting for busses for 3 separate overcrowded schools each morning the risk is much too high.

Please note that I support the business model of the daycare but not in the middle of a subdivision where children already have to play in the streets due to the lack of green space.

Our neighbor recently told us about the application to build a daycare at 110 Cheeseman Drive. This was fortunate since we didn't receive any notification from the City of St. John's about the application submittal. Even though our residence is within 150 m of the application site.

We love the location of our home especially the green space in front of it. When buying the property from Fairview Investments in 2011 we were told the building lot (50 ft x 100 ft) at 110 Cheeseman was commercial but wouldn't extend down in front our home. A commercial building in front of our residence will only bring down the value of our property.

At times the amount and speed of traffic travelling on Teakwood Drive is high but that's something we have to live with. 

Below is a concern my family has regarding the construction of a proposed daycare at the intersection of Teakwood Drive and Cheeseman Drive in Southlands. My wife has sent these two emails to the City Officials below. I would also like to voice my concern. Please consider the impact the construction of this facility would have on the residents of the immediate area, those of us living on Teakwood, Cheeseman, and Sequoia.

At present, residents of both Sequoia and a significant portion of Cheeseman Dr. have essentially one primary exist out of Southlands and that it through the Cheeseman/Teakwood intersection. In addition, multiple school busses drop off and pick up children right at this intersection, resulting in quite a bit of foot traffic and congregations of families waiting for busses. A third element that adds yet more traffic (both vehicle and foot traffic) are two Canada Post super mailboxes (located on each side of Teakwood), not to mention a busy entrance to a walking trail. Needless to say, the Cheesman/Teakwood intersection is already quite a busy spot in this section of Southlands, if not the busiest.

Despite the above, I have no issue with a Daycare or any other business operator. I'm all for commercial development; however, my issue is with commercial zoning in the heart of a residential area. I understand the complexities this causes: the land was acquired with commercial intent likely some time ago. I don't believe it's the norm to have commercial activity deep into a residential area. It is not unheard of but certainly seems out-of-step with residential green space and playgrounds. Teakwood Drive (certainly not Cheeseman) is not what I would consider a main thoroughfare where you would expect commercial activity. An area such as Southlands Blvd would be a more advantageous area.

I understand that this piece of land is zoned for commercial use but I truly believe this zoning needs to be reviewed. I just do not believe any commercial activity would be practical or safe based on the already large amounts of traffic and congestion present in the area. The noise volume will also increase as a result of commercial activity. It would fit the neighborhood better if, indeed , this area was rezoned for residential use.

Personally, I struggle with the fact that others living further away than the immediate area, not being directly impacted by such construction, are so quick to support this application. There are many in the immediate vicinity that are opposed to this Daycare construction. Those not directly affected by the traffic, noise, and construction will undoubtedly quickly say "yes" without really considering the negative impact of our area.

Finally, I'm genuinely interested in why a proposed dog park in this area was denied within the last few years? Was it based upon more foot and vehicle traffic in the area? Safety concerns were perhaps voiced, just as I am voicing my concern over this Daycare proposal.







I've lived at since September 2015 and since then I have observed a steady increase in traffic flow and speed of vehicles travelling in the area. Cheeseman Drive is already a main thoroughfare with the Glendenning Golf Course and the newly developed Galway expansion. A facility such as a 60 child daycare would be a major safety concern for our community. It's only a matter of time, until a young person gets struck and killed on Cheeseman, Teakwood or Cypress. 

I am writing today in regards to written notice received on Wednesday April 15, 2020 of an application received by the City of St. John's by Teddy Bear Childcare in order to purse construction of a Day Care Centre at 110 Cheeseman Drive, St. John's.

My husband and I are supportive of the application and use of 110 Cheesman Drive for a licensed child care centre; however, we would kindly encourage and request that the City considers to undertake a traffic assessment of the immediate area around the proposed location of 64 Teakwood Drive to 110 Cheeseman Drive to ensure the safety of the area for an additional volume of 60 young children.

Traffic and excessive speed along Teakwood drive between the location of the community mailboxes and 102 Teakwood and 110 Cheeseman is very high; the speed of cars travelling the north, less populated end of Teakwood has become dangerous; additional traffic calming controls (speed bumbs, signs?) may be warranted to ensure the safety of moment for very young children within this geographic space. Unfortunately, the automobile speeds appear highest during the morning and evening commutes between 7:30-8:30am and 4:30-5:30pm - the same time of day when children will experience the largest movement in and out of the daycare.

Ourselves and many neighbours on have become increasingly aware of the excessive speeds: we no longer allow our primary-aged children to catch the buses without adults accompanying them to cross the road to ensure they aren't hit by an auto speeding around the blind curves near the mailboxes. We are fully supportive of a

daycare but do feel that if this application is permitted, a traffic assessment is advised to ensure the safety of the area for the children moving within it.

My name is and I am one of the developers looking to build Teddy Bear Daycare at 110 Teakwood Drive in Southlands.

I wanted to write an email regarding our recent application to build a daycare on the corner of Teakwood and Cheeseman.

Originally when we were offered the option to purchase the land, we looked at building a store with two floors of residential above. We found several very desirable plans that would fit the lot and attracted a lot of interest from potential tenants. Ultimately, we changed direction of use of the land. Not because our plan was not permitted. Rather, a family member came to us with her dream of opening a daycare.

Being a Southlands resident and a father of three, I knew the lack of daycares in the area firsthand. It took me 18 months to find suitable care for my son - I had to drive to Mount Pearl to drop him off and pick him up everyday. This would have been unnecessary if Teddy Bear Daycare had existed.

We have spent the last year and a half planning this AMAZING childcare centre. This will be like no other daycare around here. Every detail has been thought of. Not just for the centre, but also the for the neighbourhood.

Teddy Bear Daycare will be offering Southlands residents the first opportunity to join. Having a local customer base will mean NO extra traffic concerns for the area. As these same families would have been travelling in the area anyway. Also we chose this location just for that, location. Being on a corner of two "Drives" it will make entering and exiting the centre a breeze. Both Teakwood and Cheeseman are designed to handle a business like this, as they are both wider than an average St.John's street. We will have an entrance on both!

Teddy Bear Daycare is a fully regulated centre. We have consulted Early Learning and Child Development Division, Dept. of Education, engineers, architects and government services. During these talks we had a choice of size of centre, 60 or 120 children. We chose the smaller number to keep the size of the building small and more visually appealing. In actual fact it is not much bigger than some of the homes in the area! It has a real "school house" look, which we LOVE!

Being a fully regulated facility comes with a major neighbourhood advantage, GREEN SPACE! We are required to have 7 square meters of outdoor space for every single child. Most every other development opportunities would reduce this green space considerably. We went further and kept much more space for something I will bring up later. We plan to keep our landscaping very simple and incorporate play areas into the natural landscape. So no eyesores for the residents living nearby.

Teddy Bear Daycare will be a state-of-the-art secure facility. We will have 24-hour security. Including 360 degree cameras and a fully locked-down building. To enter the facility you will have to have a swipe card (staff) or be buzzed in. This will help alleviate any security concerns for neighbours. We will be your eyes in the sky keeping our neighbourhood safe.

One HUGE advantage to our facility is that we plan on having a newborn room. This is something that is in great need in our area! In actual fact we only have 5 homerooms, creating a great learning environment for all the children that attend.

Another AMAZING feature of our daycare is our "indoor/outdoor romper room". This approximately 20x40 room on the ground floor will be a walkout to the garden. It will also offer exercise opportunities to the children on those not-so-nice days. This is a very unique feature to our centre.

Now let's talk about that extra land that I spoke of earlier. We would like to propose to the city that it would be a community garden that we would help support. Let's face it, that would be a great addition to our community. We will take control of watering and hiring local experts to help assist in planning of this much needed space.

As I am sure you aware of some of the fully-permitted uses of the land. None of which require community consultation. We believe that the aforementioned store/residential mix building would be a quickly-rented facility. However, some other permitted uses are; clinic, adult day home, retail store, vet clinic, service shop and laundromat. All of which I believe would create a much larger traffic problem.

Then there is our hours of operation: Teddy Bear Daycare will be operational 7:30-5:30 M-F, meaning no evening or weekend traffic at all! A store could be open 12 + hours a day, 7 days a week. Just imagine! But, again fully permitted with no consultation of neighbours.

Then there is the building size. Given the size of the lot, Teddy Bear Daycare is taking up a very small footprint compared to most every other opportunity.

The final advantage to our area is employment. There will be 12 full-time jobs created with this business. Not to mention all of the other economic benefits that come along with an operation like this.

I want to thank you for taking the time to read this. Hopefully you can see all the positives this will bring to our great city!


